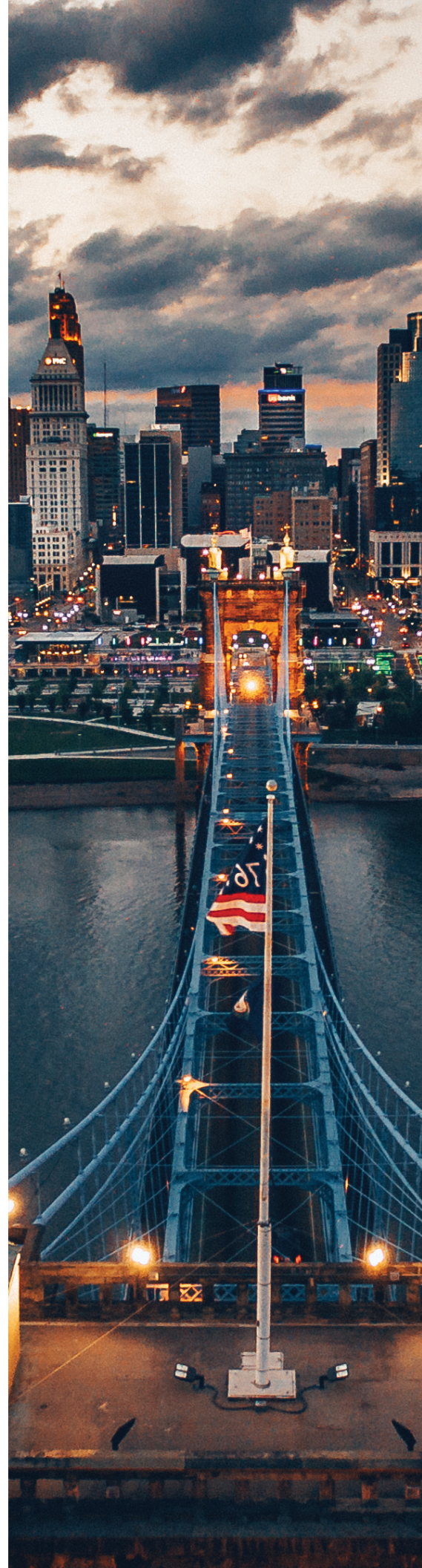

GOVERNANCE & ORGANIZATION

Cincinnati operates under a charter that combines elements of both a strong-mayor and council-manager form of government, ensuring responsive leadership and efficient city management. The Mayor, elected to a four-year term (with a two-term limit), leads alongside a nine-member City Council, elected at large for two-year terms. The City Manager is appointed by the Mayor with approval by Council and is responsible for the appointment of officers and employees in the administrative service.

Cincinnati is a full-service municipality, providing fire and police services, as well as parks, transportation and engineering, building and inspections, sanitation, to name a few of the many public services to residents, visitors, and businesses alike.
